
Funded by UK International Development, XCEPT offers actionable research to inform policies and programmes that support peace.



The programme includes the **XCEPT Research Fund** (XRF) to commission high-quality new research.

# About this funding opportunity

## Connecting informal cross-border trade, climate adaptation and instability

- In conflict-affected borderlands, weak or absent governance leaves communities to face climate shocks largely on their own.
- Informal trade networks can serve as vital lifelines during climate extremes.
- Armed actors may partner with local communities, acting as de facto regulators of trade and gaining legitimacy in the process.

# About this funding opportunity

**The consequences of these dynamics for peace, security and long-term climate resilience remain poorly understood. There is limited evidence on:**

- How informal, cross-border trade functions as a **strategy for climate change adaptation** in conflict-affected borderlands
- How the expansion of informal trade networks, driven by climate extremes, might **contribute to conflict and instability**

# Thematic scope

**This funding opportunity seeks to fund research that considers the following interlinked research questions:**

1. How do communities in conflict-affected borderlands **draw on informal, cross-border trade networks to adapt to climate extremes**? How are existing trade networks utilised or new ones formed?
2. How effective are such networks as a form of **climate change adaptation** and resilience-building?
3. Under what conditions do such informal, cross-border **trade networks fuel instability and conflict**, and what are the implications for local communities and climate adaptation?

# Approach

**We encourage a comparative approach that allows for examination of the three interlinked research questions through a limited number of cases.**

- Case selection should be designed to facilitate **structured comparisons**.
- The successful project is expected to make **a meaningful contribution to academic debates**, while also raising **policy relevant considerations**.
- XCEPT supports researchers to integrate **remote research methods** (such as satellite data) with field data collection and other data sources.

# Geographic scope

**The proposed research should concentrate on XCEPT's core geographic regions, which include fragile and conflict-affected areas of:**

- The Middle East, especially Syria, Lebanon, Iraq and Yemen
- The Horn of Africa, especially Sudan, South Sudan, Somalia and Ethiopia
- Coastal West Africa and the Sahel
- Afghanistan and Pakistan
- Myanmar

Proposals that address other geographies will be considered. Research may focus on a single region or span multiple regions, with particular interest in research that offers **comparative value** for XCEPT's core areas of focus.

- **Public-focused outputs:** commentaries, blogs, podcasts
- **Complementary activities:** Opportunities to present at events, webinars and policy briefings

Applicants should list the outputs they plan to produce in the Application Form

- **New and novel**
- **Use rigorous and robust research methodologies**
- **Adhere to internationally recognised ethical standards**

# Who can apply?

**This funding opportunity is only open to organisations.**

- Applications from **consortia, partnerships, or networks** are welcome; a lead organisation must be designated.
- **Government bodies (national, regional or local) are not eligible for this opportunity.** This exclusion does not apply to publicly funded, independent, and non-political research institutes.
- **Multilaterals** can apply.
- Applicants must name a **Principal Investigator** and Co-Investigators, if relevant.
- Researchers and research organisations based in or from countries in the **Global South** are encouraged to apply.

# How to apply?

## Stage 1: Concept Note

To apply at the Concept Note stage, applicants should prepare and submit the following documents:

### Application Form, including:

- **Concept Note** (max. 1200 words), incl. sections on: Research idea and evidence gap; methodology; outputs; team. References to literature in the footnotes will **NOT** count toward word limit.
- **Summary Budget** - high-level breakdown across major categories (e.g. personnel, activities, equipment, etc.). This should include costs related to fieldwork, editing and publication, dissemination, etc. + reasonable overheads as applicable.

### Annexes:

- CVs of Principal Investigator and Co-Investigators (as relevant) (max. 3)

## Stage Two: Project Proposal

- Shortlisted applicants will be asked to complete a full technical application, providing past performance examples, completing due diligence forms, and submitting a detailed budget and workplan.

# Scoring criteria

Applications will be evaluated by a Selection Committee based on the criteria below. **Please note that this award criteria should be considered as a guide only.**

Evaluation criteria	Scoring
<p><b>Research idea and evidence gaps</b></p> <ul style="list-style-type: none"> <li>• Relevance to the themes, questions, and XCEPT focus geographies described in this call.</li> <li>• Clarity of the proposal, clear description of the conceptual framework, and precision of the research question(s).</li> <li>• Originality of the proposed topic, awareness of existing literature and evidence gaps.</li> <li>• Consideration and integration of relevant gender dimensions.</li> </ul>	40
<p><b>Methodology</b></p> <ul style="list-style-type: none"> <li>• Aptness of the methods proposed, including rigour and robustness of the empirical strategy to address research questions and test hypotheses and of the approach to data collection and analysis.</li> <li>• Feasibility of the methodological approach, based on the time and budget proposed.</li> <li>• Robustness of quality assurance processes built into the design, implementation, writing, and dissemination of the research proposed.</li> <li>• Aptness and robustness of approach to ensuring ethical research standards throughout the project cycle.</li> <li>• Integration of gender- and conflict-sensitive research practices from design to implementation.</li> <li>• Feasibility and realism of plan for accomplishing the deliverables and delivering on time and within budget.</li> <li>• Relevance and aptness of proposed outputs for academic and policy impact.</li> </ul>	30
<p><b>Research team</b></p> <ul style="list-style-type: none"> <li>• Academic credentials and experience delivering research related to the research idea.</li> <li>• Track record using the proposed methodology.</li> <li>• Relevance of existing networks for research access.</li> <li>• Evidence of ability to produce rigorous, high-quality research outputs.</li> <li>• Extent to which individuals and/or organisations from the Global South lead and meaningfully participate across the research cycle, from research design to data collection, analysis, authoring, and uptake.</li> </ul>	30
